The applicant shall provide such additional information as may be required by the Village Clerk or Police Chief, in the interest of the health, safety and welfare of the residents of the Village including, but not limited to, details of denial or revocation of a similar license by other municipalities within the past year preceding the date of this application.

I. Fees. In accordance with Village Code Chapter "Fees", a non-refundable application fee of \$50 is required to initiate the application process. Upon approval of the application and in accordance with Village Code Chapter \_\_\_\_\_, the fee for the license is \$200.00 for 1 year or \$50 for 1 month. Each additional agent shall pay a fee of \$100.00 for 1 year or \$25 for 1 month.

A non-refundable Money Order or Bank Check is required for the above fees.
