## **SEPTEMBER 14, 2020**

The seventeenth regular meeting of the Board of Trustees of the Village of Lakewood, N.Y., was held Monday, September 14, 2020, 6:30 pm, with Mayor Randall G. Holcomb presiding. Trustees present were Ellen E. Barnes, R. Richard Fischer and Douglas L. Schutte. Trustee Edward J. McCague and Fire Chief Kurt Hallberg participated through Zoom.us. Also present were Village Clerk Mary B. Currie, Village Treasurer Apryl L. Troutman, Village Attorney John I. LaMancuso and Building Inspector Jeffrey A. Swanson. Absent were Police Chief John R. Bentley and DPW Supervisor Thomas R. Pilling.

# **REPORTS**

Mayor Randall Holcomb began his report by thanking all who assisted with the completion of the Joe Johnson legacy garden in front of the Village Hall. He said Marlinski Landscaping did a terrific job with the landscaping and thanked DPW Supervisor Thomas Pilling and his crew for clearing out the five foot hedgerow to prepare for the new plantings.

Mayor Holcomb thanked the Highway Department for all the hard work they do every day in the Village of Lakewood.

Mayor Holcomb reported with the recent completion of the road paving on East Terrace Ave., also known as County Highway #110, he has been able to obtain pavement markers to identify a new crosswalk at the Community Park, between the parking lot/dog park and the boat launch/pavilion area. Mayor Holcomb thanked Chautauqua County for their assistance in obtaining the markers.

Mayor Holcomb said longtime resident Mrs. Josie Caprino and widow of the late Mayor Anthony C. Caprino, has sold her house and moved to Ohio to live with her daughter. He added she will be dearly missed.

Mayor Holcomb was sad to announce the passing of long time village resident Tillie Solomonson, at the age of 92. For decades Tillie served on many committees in the Village of Lakewood and was very proud to be the daughter of former Village of Lakewood Mayor Nels Carlson.

Police Chief John R. Bentley submitted the Lakewood-Busti Police Department's Incident Analysis Report saying they had four hundred fifty eight incidents for the period of August 24, 2020 to September 14, 2020.

Fire Chief Kurt Hallberg submitted his report for the Lakewood Fire Department stating there has been six hundred alarms year to date with seventy-seven in the month of August and thirty so far in the month of September.

Chief Hallberg said the Lakewood Fire Department has one member that has successfully completed the Advanced Emergency Medical Technician-Paramedic (AEMT-P) course. Chief Hallberg noted the LFD now has four Paramedics and proceeded to congratulate LFD member Brandon Fardink on becoming its latest AEMT-P course graduate.

Chief Hallberg also said the Fire Department currently has five members enrolled in the Basic Exterior Fireground Operations (BEFO) course which is the first course that has to be taken before a member becomes an "Interior Firefighter".

Chief Hallberg said he is very pleased to see that several youthful and enthusiastic individuals have recently joined the Lakewood Volunteer Fire Department.

Building Inspector Jeffrey Swanson reported he has been very busy lately. He recently charged someone for building without a permit and explained the fee schedule for building without a permit is one hundred dollars plus thirty dollars per square foot.

Mr. Swanson also indicated he is continuing to review the drawings and plans for the large single-family residence currently under construction on the corner of W. Summit St. and Sunset Ave.

Trustee Barnes reported she and Trustee Fischer have met with the Department Heads and begun discussing updates to the Village of Lakewood Policy's & Procedures Agreement for non-union employees.

Trustee Barnes also indicated there is a moral problem with Police Officers right now because of everything that is going on. Ms. Barnes said the Village of Lakewood supports our local officers and asks if anyone sees a Police Officer to please tell them how much they are appreciated.

Mayor Holcomb said he has received an Appraisal Analysis from Mr. Thomas Turner of Century 21 Turner Brokers, on the paper streets, Gorden and Midcrest, which he read.

Dear Mayor Holcomb,

As requested, I went out to see the vacant paper streets on Summit/Gorden and Maplecrest/Midcrest. These paper streets are of no use to anyone but the adjoining neighbors and really there is no market value beyond what neighbors would be willing to pay to create a description and deed for transfer. The village actually has a long history of dividing the streets amongst adjoining landowners. They did it for me years ago down on Olive Ave. Should you have any question, please feel free to call.

Mr. Looker also asked if there has been any word on the grant money for the Green Street Retro Fit Project and if it will he held up because of the Federal & State huge deficit.

Trustee Schutte said the village has been told the money for the Green Street Retrofit project has already been secured.

Trustee McCague indicated all grants within New York State have been allocated and budgeted, therefore there should not be any held up.
